Abandoned Kayaks, Canoes, and Paddleboats Must be Removed

Hi CAP Community -

Our goal is to provide the best common areas for us all to enjoy. To do this, we need your cooperation. We have established a Kayak Rack Fee and now have kayaks in assigned slots. We have a waiting list for Kayak storage slots and we are considering adding another kayak rack to accommodate all CAP Members who need a slot.

There are kayaks and a paddleboat that need to be taken home and stored at home, until we have a space for them.

We do not and cannot provide paddleboat storage. We will do our best to provide additional kayak/canoe storage slots, but we need your cooperation in removing any kayaks, canoes, or paddleboats that you own. If these are not removed, they need to be considered "abandoned". We have asked for these to be removed on neighborhood signs, the website, and newsletters. Communities with Kayak racks have assigned slots and routinely remove abandoned kayaks/canoes that do not have a slot assigned – and we will also do this.

Proposed Rule:

Prohibition of Personal Storage on CAP Community Areas and Process for Disposing of Same

No personal property shall be stored in CAP community areas.

Any property left in CAP community areas for more than 30 days other than in a paid-up kayak

rack slot will be considered abandoned and subject to disposal.

If the BOD has records indicating a past owner of the watercraft, that owner will be contacted

by mail. In any case, notification of presumed abandonment will be posted in CAP

communications (website, road sign and facebook.)

If the property is not claimed within 30 days of announcement, it will be donated to charity.

The BOD will retain donation receipts for one year.

If the owner cannot retrieve the property within 30 days, a request may be made in writing to

have the property moved to the owner's home.

The BOD may move abandoned property to another location within CAP pending disposition.

Locks securing personal property to common areas may be cut.

This rule will go into effect on 8/1/2024, assuming passage by the BOD and distribution of the approved rule to residents has occurred by that date.
